1) **Financial:**

3) **Road Committee:**

a) We will have a final grader pass on the Ranch before snow comes. There was talk about plowing on unimproved areas, and plows will not go where they could get stuck. Please reach out to the board if you see any problem areas that need to be addressed. There has been a lot of visual evidence of destructive driving, discussions on how to manage. Please remind your children and or guests that fines will be levied if tracked to your lot.

4) **Architectural Committee:**

a) Approval for 3 improvements. Multiple improvements approved; committee recommends checking with Duchesne County to ensure you are aware of any permitting needs.

5) **Dumpster/ Weeds Committee:**

a) Fencing is up and board working on installing concrete barriers to keep dumpsters in place and keep fence from being damaged. Dumpsters have been doing better, keep up the good work.

6) **Open Issues:**

a) Dark skies initiatives, approximately 9 left on Ranch. Another round of letters will go, working to get all removed. CCR's were updated in 2021 and they are not allowed on Ranch.

b) Camp fires allowed in approved pits, no open burning

c) Thunder Ridge HOA president to send link to their website, so people can link over.

d) Hunting on Oakhills Ridge, they are using access thru Bandanna as a road was created on private property, will work to close access thru Bandanna.
